This contract stipulates that Bridal Artistry will provide on-site makeup services for the wedding of _____ on _____.

I understand the fee for the bride's makeup will be a total of \$320, which includes the pre-wedding consultation and a full-size lip color or gloss + false lashes, if desired.

For an additional fee of \$100 each, Bridal Artistry will provide makeup services & a lip color/gloss (false lashes + \$10) for the following members of the party*:

**Numbers are locked in 1 month before the wedding & cannot be reduced (add-ons may be possible)*

A travel fee of \$30 per artist/stylist will be added for wedding services on-site over 8 miles outside the Washington Beltway -- \$50 if beyond metro area. Any necessary parking fee will be paid also by the bride.

A \$220 non-refundable deposit by cash or check will be required to reserve services for the wedding date. Balance is due on the day of the wedding (cash preferred). Cancellation within 1 month of the wedding date is subject to an additional \$200 cancellation fee.
